

MEMORANDUM OF UNDERSTANDING

BETWEEN

**CZECH OFFICE FOR STANDARDS, METROLOGY AND TESTING
(UNMZ CZECH REPUBLIC)**

AND

**EGYPTIAN ORGANIZATION FOR STANDARDIZATION
AND QUALITY
(EOS ARAB REPUBLIC OF EGYPT)**

**IN THE FIELDS OF
STANDARDIZATION, CONFORMITY ASSESSMENT AND
METROLOGY**

The Czech Office for Standards, Metrology and Testing (UNMZ, the Czech Republic) and the Egyptian Organization for Standardization and Quality (EOS, the Arab Republic of Egypt), hereinafter referred to as the "Parties",

- desiring to develop cooperation in the fields of standardization, metrology and conformity assessment procedures based on European and international principles, regulations and standards;
- taking into account the importance of live protection and health and environmental care,
- guided by the economic interests in both states of Parties, Parties have agreed as follows:

1. The Parties within their competence and in accordance with the legislation of their countries express desire to cooperate in the following areas:

- providing information on standards and technical regulations adopted in the Arab Republic of Egypt and European Union's legislation introduced in the Czech Republic;
- exchanging of information on the certification bodies and testing laboratories the Arab Republic of Egypt and authorized persons and notifying the Czech Republic;
- conformity assessment in order to ensure conditions for the possibility of recognition of testing results in accordance with the laws in force in both Parties;
- exploiting the opportunities of authorized persons of the Czech Republic in conformity assessment of Egyptian products placed on the single market of the European Union;
- training specialists of the Parties in professional educational systems related to upgrading skills of these professionals;
- implementing of a collaborative study;
- comparing national measurement standards unit quantities;

- using of reference on materials defined composition, properties of substances and materials of data on physical constants and properties of substances and materials;
- recognizing testing results according to the agreed term and conditions with the aim of type approval based on verification and calibration of measurement instruments supplied mutually by the Parties.

2. The Parties are intending to promote the cooperation under the paragraph 1 in following ways:

- exchanging national legislation, technical regulations and other normative documents;
- preparing of joint projects in case of mutual interest;
- organizing training courses, seminars and symposiums, meetings of experts;
- exchanging scientists, engineers, technicians and other specialists to carry out joint projects;
- arranging of internships and study visits for experts;
- sending Egyptian specialists and lectors to the trainings in the Czech Republic, providing training to Czech experts at the corresponding educational institutions of Egyptian Party;
- exchanging of information, opinions, experiences, publications, reports and other fields of knowledge according to the mutual interest.

3. In the case of mutual interest the Parties may within their competence and in accordance with the legislation of their countries settle on the specification of individual areas of cooperation.
